EUTHANASIA, ASSISTED SUICIDE

It is hard to see someone we love suffer. Someone that once was strong, perhaps a parent or a friend that we have looked to for support now vulnerable and in pain. Euthanasia or assisted suicide is a difficult topic to discuss because it is a very emotional one.

I personally, do not support assisted suicide or euthanasia. I do understand that people should have the right to choose to live or die. We sadly see many suicides. Medications that can bring this about are readily available. People have the choice not to be resuscitated, and it is not uncommon for our elderly to mix up their medications.

Palliative care was set up so that people who were not going to recover or were nearing their time of passing could pass with dignity surrounded by those that they love.

We have good palliative care and pain management in Australia. I personally knew three people who were given an overdose of morphine to assist them in passing whilst in palliative care. I understand that this is not uncommon.

For me there are too many variables to be able to vote with a good conscience a yes to Euthanasia.

Firstly I value Life, I believe it is a gift.

Assisted suicide or euthanasia because people just don't want to live is not something I could support. Maybe I am naive but we are not yet a world without hope.

My concerns are many if we open up the door to telephone assisted euthanasia, and euthanasia in general. I believe that we leave ourselves open to becoming hardened to the sanctity of life, and there are risks. Let me try and express my concerns.

I have concerns that there are people that may have regrets at the last minute and ambulances will be overburdened with prioritising these persons, instead of focusing on those who want to live but are in crisis. I have concerns that unscrupulous family members may take advantage of vulnerable people to gain access to inheritances early. I have concerns that persons involved in domestic violence or who have previously been involved will assist people in dying for their own purposes.

I have concerns that our elderly will find themselves checked out earlier than necessary by a public that consider them a burden on society.

I have concerns that not every assisted suicide will be that, an assisted suicide.

As I said at the beginning of this topic it is hard to see someone we love suffer. I have personally experienced and walked through this, but I still cannot turn my back on hope. Hope for a cure, Hope for a healing, Hope for a miracle.

I apologise if my stance offends anyone, and I respect everyone's right to their own opinion. But this is where I sit on a difficult emotional topic.

ABORTION TURNING THE CLOCK BACK

The most un-Australian legislation was passed in 2019, 2020. Not long after the 2019 Election our Politicians voted for full term Abortion. *Please see below for what this looks like for the child. ⁱ

No pain relief to be given. This barbaric behaviour would rarely be found in the animal kingdom.

Abortion because of gender selection is allowed. The excuse given was women's rights. The lie that was fed Australians was that abortion previously had been illegal. This is not true, I personally know women and knew women in the 1980's that were legally allowed abortions in hospitals round the ACT and NSW for medical grounds. Women who did not understand the development of the child, but had abortions because they were single mother's and did not feel they could emotionally cope with raising a second child. Women who had not one, or two abortions but up to 5 abortions as a form of birth control.

Abortion was allowed up to 20 weeks and even later in extreme cases.

So why did we need to feed the lie to Australians that women did not have a right?

I would ask the question why would someone need to wait 6 months and longer to decide to have an abortion?

I respect women's rights and women's bodies, but I respect the unborn child. The one who had no say in being conceived, the one that was brought about by often a willing act.
